Re-issued: 01/03/2023 (1st Issued: 08/17/22). The work involves responsibility for supervising the activities of subordinates administering social services in specified areas of programs. An incumbent's core responsibilities are to support, administer and educate. This is achieved through the core competencies of communication, systematic monitoring, feedback, coaching and maintaining a supervisory focus emphasizing relationships and results. The work is performed under general direction in accordance with established policies and procedures. The employee is responsible for recommending Social Services policies and procedures. Direct supervision is exercised over the work of Senior Caseworkers, Caseworkers and assigned clerical staff. Does related work as required.

The title of Case Supervisor, Grade B is **Competitive**, requiring applicants to meet minimum qualifications established for the position and successfully meet civil service examination requirements. **An examination is expected in 2023.** A provisional appointment may be made to this position (pending a criminal background check* for external candidate).
