NOTICE OF VACANCY COMMUNITY SERVICES WORKER

Issued: 05/05/2023. The work involves responsibility for performing supportive services to aid in implementing a variety of programs and their delivery to clients. Although detailed instructions are given for new or difficult assignments, and procedures are rather definitely fixed, employees must exercise independent judgment in applying them to specific cases. The work is performed under the general supervision of a higher-level staff member. Supervision is not a responsibility of this class. Does related work as required.

The title of Community Services Worker is **Competitive**, requiring applicants to meet minimum qualifications established for the position and successfully meet civil service examination requirements. **A test date for this examination is expected in August 2023.** Permanent appointment will be dependent upon participation in the examination AND being reachable from the resulting eligible list.

Status: Provisional, pending successful completion of civil service examination requirements
Work Hours: Full time, days; 35 hours/week
Salary: \$30,224 (CSEA SG IV); benefit package available including: health, dental and vision insurance, paid leave time, NYS Retirement System, Deferred Compensation Plan
Location: Tioga County Department of Social Services

Minimum Qualifications Either:

- a) Graduation from high school and one year of full-time experience involving direct client contact in a position supporting the program provisions in a public or private agency; **OR**
- b) Two years of full-time experience (or it's part-time equivalent) as defined in (a); **OR**
- c) Completion of 48 college credit hours from a regionally accredited or New York State registered college or university**.

****Copy of college transcript(s) or diploma must be submitted with application.**

SPECIAL REQUIREMENT: Verifiable part-time and/or volunteer experience will be pro-rated toward meeting full-time experience requirements. Certain assignments made to employees in this class will require him / her to meet field work requirements during the ordinary course of business in a timely and efficient manner.
