NOTICE OF VACANCY ACCOUNTING ASSOCIATE III

Date of Issue: 05/23/23. The work involves responsibility for planning, assigning and supervising major account keeping activities and/or independently performing difficult and responsible account keeping functions electronically, on hard copy or both. Incumbents will use various financial software programs. Work is performed under general supervision in accordance with specific law, office rules, procedures and/or policies. Independent judgement is exercised in planning and carrying out the details of the work. Difficult technical or policy problems are referred to a supervisor for decision or review of judgment. This class differs from that of Accounting Associate II by the more difficult and complex nature of the assignments and the independence allowed in carrying out the work and/or by the supervisory responsibilities of subordinate staff. Does related work as required.

The title of Accounting Associate III is **Competitive**, requiring applicants to meet minimum qualifications established for the position and successfully meet civil service examination requirements. **An examination is expected for 2024.** Pending a criminal background check*, a provisional appointment may be made to this position. Permanent appointment will be dependent upon participation in the examination AND being reachable from the resulting eligible list.

Work Hours: Full time, 35 hour work-week

Promotional Qualifications: At time of application, candidate must be currently employed and have **Six (6) months** continuous **permanent** competitive class **status** as an **Accounting Associate II**; **OR Eighteen (18) months** as an **Accounting Associate I** within a **Tioga County Department**.

OPEN COMPETITIVE QUALIFICATIONS: Graduation from high school or possession of a high school equivalency diploma **and either:**

- a) Graduation from a New York State registered or regionally accredited college or university with an associate degree in accounting, business, or a closely related field and one (1) year of full-time work experience (or its part-time equivalent) in maintaining financial accounts and records; **or**
- b) Three (3) years of full-time work experience (or its part-time equivalent) in maintaining financial accounts and records; **or**
- c) An equivalent combination of training and experience as indicated in a) and b) above.

If requested, a candidate will be required to authorize access to educational, employment, financial, or other records.
