

The online application portal is accessible if using a smart phone. If you are unable to apply online or if the portal is not functional, applications may be printed from our web site (*Civil Service – Application Forms*). Applications may also be obtained in our department during regular office hours.

Application Filing Fee: \$15.00*

Candidates must submit a separate application filing fee or Application Fee Waiver form for each open-competitive examination that the candidate is applying to take. The filing fee or fee waiver form for this examination must be received or post marked on or before the "Deadline to Apply" in order to be included in the corresponding test date. *Online credit or debit card payment is subject to a surcharge. Credit or debit card payment is not available if paying in person, in our office.

<u>Time and Place of Written Examination</u>: Approved candidates will be notified by admission letter 7 to 10 days prior to the written test date as to when and where to appear. **All notices of admission or disqualification will be sent by email to online applicants.** You are responsible for checking your spam folder! Applicants who do not have email will be sent notice of admission or disqualification by postal mail to the address provided. **Be sure to bring the admission letter with you to the examination.** If you have not received an admission letter **3 days before** the written test date, call 607-687-8494

Residency Requirements: Candidates ARE NOT required to be legal residents of Tioga County immediately preceding the date of the written test. Preference <u>may be</u> given to residents of the civil division in which the vacancy exists. When preference in certification is given to residents of a municipality pursuant to subdivision 4a of Section 23 of the Civil Service Law, an eligible must have been, at the time of certification and for at least four months prior thereto, a resident of such municipality in order to be included in a certification as a resident of such municipality. When a candidate's residence changes, it is his/her responsibility to notify the Tioga County Personnel Department of such change by submitting the Change of Residence Address Form. Be advised, the candidate may also be required to provide documentation to validate his/her new residence.

Minimum Qualifications for Water Treatment Plant Operator / Trainee

Trainee - Graduation from high school or possession of a high school equivalency diploma.

Operator - Graduation from high school or possession of a high school equivalency diploma **AND** eligibility for an appropriate Plant Operator's certificate issued under the provision of New York State Sanitary Code, Section 5-4.3. Possession of the certificate is required at time of appointment. Qualifications for certification vary according to the Grade of Water Treatment Plant.



<u>Local Water Treatment Plant Grading as of 10/98</u>: Town of Owego - Village of Waverly - 2A

Minimum Qualifications for Wastewater Treatment Plant Operator / Trainee

Trainee - Graduation from high school or possession of a high school equivalency diploma.

Operator - Graduation from high school or possession of a high school equivalency diploma **AND** eligibility for an appropriate Plant Operator's certificate issued under the provisions of Section 650 of the New York State Code of Rules and Regulations. Possession of the certificate is required at time of appointment. Qualifications for certification vary according to the Grade of Wastewater Treatment Plant, as determined by the New York State Dept. of Environmental Conservation (DEC).

Local Wastewater Treatment Plant Grading (2016): Town of Owego - 3A & 4A

Anticipated Eligibility: If you expect to complete the educational requirement within 12 months from date of application, you can be admitted to this examination. If successful on the examination, you will not be certified for appointment until you have submitted proof of completion of the requirements to the Tioga County Personnel Department. Failure to submit proof of your completed educational requirements within 12 months from date of application, may result in your removal from the eligible list.

<u>Distinguishing Features of the Class for Water Treatment Plant Operator</u>: This is routine but important work involving responsibility, during a shift, for the efficient operation and maintenance of a water treatment plant with facilities for the application of chemicals to the water, such as chlorine or chlorine compounds, chlorine-dioxide, chlorine-ammonia, fluoride compounds, or the process of de-chlorination or similar process. The work is performed under general supervision of an operator qualified to be in charge of the complete and actual operation of the water treatment plant. Supervision may be exercised over subordinate employees in the performance of their assigned duties. Does related work as required.

<u>Irainee</u>: The incumbent learns the duties and routines of the operation and maintenance of a water treatment plant. The work is performed under immediate supervision of a qualified operator. Employees are required to complete the training and experience requirements of the New York State Sanitary Code for a certificate appropriate to the plant and will be advanced to the operator level without further examination upon satisfactory completion of the certificate requirements.

<u>Distinguishing Features of the Class for Wastewater Treatment Plant Operator</u>: This is routine but important work involving responsibility, during a shift, for the efficient operation and maintenance of a wastewater treatment plant with facilities for chemical precipitation, sludge digestion, sludge de-watering, ultimate sludge disposal, activated sludge, stabilization or oxidation process or any other biological oxidation process. The work is performed under the general supervision of a certified operator, qualified to be in charge of the complete and actual operation of the plant. Supervision may be exercised over motor equipment operators or other treatment plant employees. Does related work as required.

<u>Irainee</u>: The incumbent learns the duties and routines of the operation and maintenance of a wastewater treatment plant. The term of appointment is dependent upon the complexity of the treatment plant operations as regulated by the New York State Department of Environmental Conservation (DEC) in Part 650 of the New York Code of Rule and Regulations. Upon satisfactory completion of the training and experience requirements as defined by the DEC, and receipt of the appropriate Operator Certification, the trainee receives permanent appointment as a Wastewater Treatment Plant Operator without additional examination. Work is performed under the immediate supervision of an appropriately certified operator. May exercise supervision over motor equipment operators or other subordinate employees. Does related work as required.

TYPICAL WORK ACTIVITIES FOR THIS POSITION ARE AVAILABLE TO REVIEW UPON REQUEST

Subjects of Examination: A written test designed to evaluate knowledge, skills and /or abilities in the following areas:

- 1. **Mechanical Aptitude:** These questions test your ability to identify and understand how basic mechanical instruments such as motors and gears work.
- 2. Safety Practices: These questions test your knowledge of basic safety practices.
- 3. **Tools and Reading of Scales and Gauges:** These questions test your ability to recognize or identify basic tools and their common uses and to make accurate readings of various types of dials, scales and gauges.

- 4. **Elementary Chemistry and General Science:** These questions test your knowledge of basic processes and concepts in chemistry and general science.
- 5. **Understanding and Interpreting Written Material:** These questions test how well you comprehend written material
- 6. **Basic Mathematics:** These questions test your ability to use addition, subtraction, multiplication and division to solve basic arithmetic problems that might be encountered in water and wastewater treatment plant operations. Questions may also involve the use of fractions, decimals, averages, and percents.

<u>Written Retest Policy</u> - Candidates who fail the written examination or candidates who passed the written examination and wish to improve their position on the eligible list, may reapply to retake the written examination after a six (6) month period has passed from the date of previous examination.

<u>Use of Calculators</u>: The use of a calculator is **RECOMMENDED**. Candidates are permitted to use quiet, hand-held, solar or battery powered calculators. Devices with typewriter keyboards, spell checks, personal digital assistants, address books, language translators, dictionaries, or any similar devices are prohibited. Cell phone calculators are prohibited.

<u>Continuous Recruitment Eligible Lists</u>: Successful candidates will have their names placed on the eligible list in order of their final score. Candidate scores from different testing dates will be interfiled on the eligible list. A candidate's eligibility for appointment begins on the date their name is added to the eligible list and they will remain eligible for appointment for one (1) year from the date. Appointments from an eligible list must be made from the three highest standing candidates willing to accept appointment.

<u>Termination of Program</u>: Tioga County reserves the right to terminate this continuous recruitment program and reestablish the periodic type of examination.

SEND CHECK OR MONEY ORDER payable to **TIOGA COUNTY TREASURER**, as directed above, and write the examination name(s) & number(s) on your check or money order. Submit this to the address above. If paying by cash, please bring payment(s) directly to the Tioga County Department of Personnel & Civil Service. As no refund will be made, you are urged to compare your qualifications carefully with the requirements for admission and file only for those examinations for which you are clearly qualified. A check returned for insufficient funds may disqualify your application and result in further action and/or service charges. *Online credit or debit card payment is subject to a surcharge. EXCEPTION TO THE APPLICATION FEE will be made for the following:

- 1. Promotional exams;
- 2. Provisional Tioga County employees who have held a permanent position prior to provisional appointment in title named for this examination;
- 3. Examination candidates receiving public assistance from a State or Local social service agency, and/or who are currently unemployed. Individuals wishing to claim this waiver of fee must complete the Application Fee Waiver Form at time of application. All information is subject to verification, and if found to be fraudulent, are grounds for barring examination or appointment.

ADDITIONAL INFORMATION AND INSTRUCTIONS

ADDITIONAL EXAMINATION CREDIT – Children of Firefighters and Police Officers Killed in the Line of Duty: In conformance with Section 85-a of the Civil Service Law, children of firefighters and police officers killed in the line of duty shall be entitled to receive an additional ten points in a competitive examination for original appointment in the same municipality in which his or her parent served. If you are qualified to participate in this examination and are a child of a firefighter or police officer killed in the line of duty in this municipality, please inform this office of this matter when you submit your application for examination. A candidate claiming such credit has a minimum of two months from the application deadline to provide the necessary documentation to verify additional credit eligibility. However, no credit may be added after the eligible list has been established.

ADDITIONAL EXAMINATION CREDIT – Veterans or Disabled Veterans desiring to claim additional credit must request and file an Application for Veterans' Credit at any time between the date of application for examination(s) and the date of the establishment of the resulting eligible list. These credits may only be used once. Effective January 1, 1998, the State Constitution was amended to permit a candidate currently in the armed forces to apply for and be conditionally granted veterans' credit in examination. You may not claim veterans' or disabled veterans' credits after the Eligible List has been established. It is the candidate's responsibility to request and submit an Application for Veterans' Credit before the Eligible List is established. Veterans' credits will only be added to passing examination scores

ALTERNATIVE TEST DATE: When a candidate is aware of a conflict prior to the scheduled test date, the candidate must notify the Department of Personnel and Civil Service in writing as soon as possible. For emergency situations that occur on the scheduled written test date, the candidate must notify the Department no later than three (3) days following the Saturday on which the written test was held. APPLYING FOR MULTIPLE EXAMINATIONS SCHEDULED FOR THE SAME DAY (Cross-Filing): You must notify all agencies with which you have filed an application of the test site at which you wish to take your examination(s). If you have applied for both State and Local government examinations, you must notify Tioga County Department of Personnel no later than two weeks prior to the test date of your intent to take both a State and a Local government examination. When taking both a State and a Local government examination you will be required to take all your examinations at a State examination center. You will be advised by letter when and where to report for your examinations.

For Tioga County examinations, the Multiple Exam Notice form must be completed. This form is available in the Tioga County Department of Personnel & Civil Service, online at www.tiogacountyny.com, or by calling (607) 687-8207. If you do not submit your Multiple Exam Notice form two weeks prior to the test date, you may NOT be allowed to sit at the test site you have selected. If you appear at a test site but did not designate this location as your test site on your form, you may NOT be allowed to take your examination(s) at that location.

<u>APPOINTMENT</u> from an eligible list must be made from the top three candidates willing to accept the appointment. The resulting eliaible list will be used to fill current or future appropriate vacancies within Tioaa County's jurisdiction.

BACKGROUND INVESTIGATION and Additional Screenings: Candidates may be subject to a thorough background investigation. If requested, applicants will be required to authorize access to educational, financial, employment, criminal history, or other records. Effective 01/01/16, a criminal background check is required prior to employment within any Tioga County department. Depending upon the position sought, conviction of a felony, misdemeanor or other offense may bar appointment. At the discretion of the appointing authority, candidates may be subject to additional screenings as a term and condition of employment, including but not limited to: fingerprinting, psychological, or drug testing. Depending upon appointing authority, applicants may be required to submit the necessary fees for the fingerprint processing. Per Tioga County Civil Service Rule IX (3): A record of disrespect for the requirements and processes of law may be grounds for disqualification for examination or, after examination, for certification and appointment.

<u>CHANGE OF ADDRESS:</u> When a candidate's residence and/or mailing address changes, it is his/her responsibility to notify the Tioga County Personnel Department of such change by submitting a **Change of Information Form.** Documentation may be required to validate a change in residence.

<u>CHANGE OF NAME:</u> When a candidate's name changes, it is his/her responsibility to notify the Tioga County Personnel Department of such change by submitting a **Change of Information Form.**

<u>DISQUALIFICATION</u>: Any applicant may be disqualified for examination, or after examination, for certification and appointment that is not in compliance with the standards and requirements set forth in Section 50 (4) of the Civil Service Law.

ELIGIBLE LIST: In accordance with Section 61 (1) of the Civil Service Law, and as determined by the Tioga County Department of Personnel & Civil Service, the eligible list resulting from this examination <u>may</u> be used to fill vacancies in similar related titles.

EVALUATION OF FOREIGN POST-SECONDARY EDUCATION: If your degree and/or college credit was awarded by an educational institution outside of the United States or its territories, you must provide independent verification of equivalency. A listing of acceptable companies which provide this service may be obtained from the following:

EXAM HOLDINGS: In the instance where both a **promotional** and an **open-competitive examination** are held for the same title, a mandated **promotional list will be used first** to fill any positions. If you meet both the promotional and open-competitive minimum qualifications, you must file a separate application and pay any required fee(s) for each exam in order to be considered.

EXPERIENCE: All experience required to meet the acceptable training and experience is full-time experience. (Part-time experience will be credited on a prorated basis.)

<u>FALSIFICATION</u> of any part of the "Application for Examination or Employment", "Change of Information Form", or any related documentation may result in disqualification before or after examination in accordance with Tioga County Civil Service Rule IX and/or Civil Service Law Section 50.4.

<u>FEES</u>: Candidates must submit a separate application fee or Application Fee Waiver form for each open-competitive examination that the candidate is applying to take. Candidates will be disqualified from taking the exam if the application fee or waiver form is not received, as directed, from the Tioga County Department of Personnel & Civil Service.

<u>FORMAT</u>: The test may be in written form or it may be administered on a personal computer (PC). The type of test will be stated on the admission notice.
