## NOTICE OF VACANCY Support Investigator

**Date of Issue: 10/02/2024:** This work involves responsibility for verifying the absence of a legally responsible relative from a household, locating the individual and assessing the possibility of obtaining reimbursement of funds. There is no responsibility for fraud investigation. The work is performed under general supervision with considerable leeway in carrying out the details of the work. Does related work as required.

The title of Support Investigator is **Competitive**, requiring applicants to meet minimum qualifications established for the position and successfully meet civil service examination requirements. **The tentative test date for this examination is not yet known.** Permanent appointment will be dependent upon participation in the examination AND being reachable from the resulting eligible list. \*Applicants not currently employed by Tioga County will be subject to a criminal background check.

**Status:** Provisional, pending successful completion of civil service examination requirements  
**Work Hours:** Full time, days; 35 hours/week  
**Salary:** \$40,212 (CSEA SG VII, base); benefit package available including: health, dental and vision insurance, paid leave time, NYS Retirement System, Deferred Compensation Plan  
**Location:** Tioga County Department of Social Services

**Promotional Qualifications:** At time of application, candidates must be currently employed AND have **twelve (12) months'** continuous **permanent** competitive class **status** as a **Social Welfare Examiner** with the **Tioga County Department of Social Services**.

### MINIMUM QUALIFICATIONS (Either):

- a. Graduation from a regionally accredited or New York State registered college or university with a bachelor's degree in social sciences, human services or related field; and one (1) year of full-time interviewing or investigating experience or its part-time equivalent involving public contact; **OR**
- b. Graduation from high school or possession of a high school equivalency diploma and five (5) years of full-time experience or its part-time equivalent as defined in (a) above; **OR**
- c. An equivalent combination of training and experience as defined by the limits of (a) and (b) above.

**SPECIAL REQUIREMENT:** Certain assignments made to employees in this class will require reasonable access to transportation to meet field work requirements made in the ordinary course of business in a timely and efficient manner.
